

It is simply important for an enterprise to know that national and international stock exchange rules require the application of internationally accepted accounting directives. So there are several good reasons for a trend towards internationalization. For an investor means internationalization usually accompanied by a standardization of accounting rules that he can compare financial statements quicker and easier. There are no longer time-consuming and expensive conversions of financial statements necessary. Internationalization means also that the national differences in the determination of profit will disappear. Standardization would give the term profit substance and would allow the comparison of financial statements of different enterprises from several countries. In the European Union enterprises have a special responsibility since 2005. On the 12th of March 2002 the European Parliament endorsed the EC Commissions proposal that all EU listed companies must follow standards issued by the International Accounting Standards Board (IASB) in their consolidated financial statements starting no later than 2005.
